

Whereas a Proposal has been made to y^e Trustees for building the Church at Hampstead by M^r Gilson (of y^e same Parish) to furnish y^e Chapel of y^e said Church with a Velvet Cushion with gold Tippets & a Vallen for y^e same Summ^r & with Gold Lace & fringe of y^e same together with a carpet & two Cushions for y^e Communion Table made of Velvet also & Summ^r it in y^e same manner - All which is to be of y^e full value of fifty pounds provided y^e said Trustees do Consent that he has a gallery kin (p. 135) on y^e South side of y^e said Church for his & his family's use (withoout paying any rent for y^e same) so long as he or they shall continue or live in Hampstead & no longer -

The said Trustees taking y^e said Proposal into their Consideration have agreed & do Consent that M^r Gilson (upon fulfilling his proposal) shall have y^e above nam'd kin for his & his family's use - See p. 168

M^r Vincent acquainted y^e Trustees that he had seen M^r Nichell y^e had spoke with him concerning y^e time of quidding y^e Chapel and that he had appointed to be at Hamp^r to morrow being y^e 8th Instant and would then fix y^e time, and also give an answer relating to y^e Pews, Galleries & chaires, set up by y^e Trustees whether he would purchase them or not -

W^m Vincent reported that he had met M^r. Mitchell on Thursday last and he desired if Trustees would put it off Chapel before Sunday or as soon after as it could be done conveniently, but refused to purchase any of y^e pew or gallery seats if there is he thought that matter required Consideration on both sides least damage should ensue upon y^e taking them away upon which it was proposed to refer it to proper workmen which was agreed to
