

Messrs. GENTLEMEN,

HAVING been invited last year to make a plan and estimate for the proposed enlargement of your Church, in aid of the labours of the Committee then sitting pursuant to the resolution of a Vestry of the Parish, relative to the subject; and having been informed that an Act of Parliament has since passed, under which you have been appointed Trustees for providing the required increase of accommodation; I beg leave to submit those plans to your consideration, accompanied by a few observations on the different modes of proceeding which may be adopted, and by some additional plans illustrative of those observations.

There appear to me to be three modes by which your object might be obtained. 1st. By taking down the West end of the present Church, and adding 28 feet to its length. Taking down all the present pews and seats, and remodelling them on a better plan, and adding another gallery for the Charity Children. Thus an increased accommodation for 524 persons might be obtained, in the following proportions :-

The manner in which this is proposed to be accomplished is shewn in my plans before submitted; and I am still of opinion that this alteration might be executed and completed, including new painting and beautifying the interior of the Church,

2d. But this plan having been considered by many as open to objection, on account of the great length that the Church would then have, in proportion to its breadth, and of the interruption of the sound occasioned by the pillars, and vaulting ceiling, which would, it is supposed, make the Minister's voice to be imperfectly heard at the extremity of the building; it has been suggested that the pulling down the present Church, and building another, would be a more eligible mode of proceeding, for the following reasons:—first, that it would more effectually answer the end proposed of increasing the accommodation, without risk of part of the congregation being unable to hear the Minister, and would admit a much better arrangement of pews and free sittings. Second, that it would make a more strong and more durable building than could be expected by adding to the present Church, independently of the consideration of the tower, which has given way, and would require to be secured if it remains standing; and, thirdly, it would be the means of having an edifice more characteristic and worthy the purpose for which it is designed, more ornamental to the town, and more creditable to its inhabitants.

The plan and elevation which I wish to submit for this mode of proceeding, is of a Church which would contain 1650 persons; 784 in pews, and 866 in free sittings, including children*.

The coping string, courses, mouldings, jaumbs, cills, and projections of every kind, would be executed in stone, and the plain parts in Roman cement; which, if properly done, and with the material of the best quality, would be, in the situation I have described, equally durable with the best stone, as I could satisfactorily prove, by pointing out buildings done in this way, which are of many years standing, and do not shew any sign of decay. The reason why cement has fallen into disrepute, is the modern practice of using it in buildings erected for speculation, and, therefore, executed in the cheapest and consequently worst manner, both as regards the cementing and the walls on which it is laid.

This Church might be erected for the sum of 10,000l., including all expenses; which amount might be raised in the following manner. The materials of the present Church would, it is fair to conclude from the appearance of the building, be worth - - - - - £2500
The Society for rebuilding and enlarging Churches and Chapels would perhaps contribute - - - - - 1000
£3500
And there would remain to be raised by loan, or rates, or voluntary contributions - - - - - 6500
Total - - - - - £10,000

3d. The third plan I would propose to the Trustees, is the building an entirely new Chapel in that part of the Parish which is considered (next to the town) as the most populous and most in want of Church accommodation; such as Kilburn, or Southend, and Pond Street, or upon the heath, at the top of High Street. For this purpose, I have given a design consisting of plans, sections, elevations, and a perspective view of a Chapel calculated to hold nearly 800 persons on the ground floor, and 114 children in a gallery at the West end; and thus divided:

It is so arranged that a gallery for 300 persons might be added, in case an increase of population should hereafter render more accommodation necessary.

The exterior of the design would, of course, be liable to alteration, depending on the situation of the ground intended for the site.

The cost of the Chapel, supposing it to be built conformably to the rules observed by his Majesty's Commissioners, in the Churches and Chapels to which they contribute, would be, according to a detailed estimate, and

including every expense - - - - -	£6250
A gallery for 300 persons (if it should be required) - - - - -	500
Total - - - - -	£6750

* This plan is made expressly for the present purpose. The elevation is that of a Church I am about to begin, under his Majesty's Commissioners, in Staffordshire.

Of this amount, it is very likely the Commissioners would contribute about 3100l., which would leave to be raised by the Parish about - - - - -	£3150
To this must be added the repairs of the roof, tower, and front of the present Church, supposed to amount to - - - - -	1000
And the remodelling the pews, painting, &c. all the interior - - - - -	1000
Enclosing the site, approaches, &c. supposed to be - - - - -	300

With regard to the respective merits of the three modes here proposed, there cannot, I think, be a question but that either the second or third would be the most effective; and the difference in the cost of each is not very considerable.

The decision between the second and third plans must chiefly depend upon the question, whether the additional accommodation is most wanted in the town or in some other part of the parish.

I have inclosed the printed forms used by His Majesty's Commissioners for building new Churches, and also those of the Society for rebuilding and enlarging. It should be observed that the Commissioners for building new Churches will not contribute to the rebuilding of any Churches or Chapels already erected. And although there is every probability that the Society for rebuilding and enlarging Churches and Chapels would contribute liberally, in proportion to their means, to the rebuilding Hampstead Church when so considerable an outlay would have to be made, yet it is not to be expected they will contribute any thing to the enlargement and repair of the present Church, as from the respectability of the town, and the small amount of the expense, it would not be a case that would seem to have an urgent claim to their assistance.

If a new Chapel should be determined on, there is every reason to expect that His Majesty's Commissioners would contribute about one half of the expense; but the site, the inclosing it, and, if new roads and approaches to it are necessary, the making them must be paid for by the parish; and the manner in which a minister is to be paid for the separate congregation, must also be arranged.

Although the subject of the quantity of Church accommodation required at Hampstead, is not one on which I can be expected to be so well informed as yourselves, it may perhaps be permitted me to state what has been thought necessary, in other places, where new Churches and Chapels have been built.

One fourth of a population is, I believe, considered the least that should be provided with Church-room; and many applications for aid to erect new Churches have been made and complied with in places where the existing Church accommodation amounted already to one fifth. It is not merely the number of sittings which is considered, but the question depends also upon the proportion of the existing accommodation that is left unappropriated for free-seats. Hence proprietary Chapels are not taken into account, because the seats in them are under the control of the proprietors, and also because their permanency cannot be calculated upon.

I should therefore think, that in the parish of Hampstead, the population of which is calculated at 8000 persons, there certainly ought not to be less Church accommodation than for 2000 persons, of which between one half and one third should be in free-sittings. The present Church contains seats for 1050 persons, and of these 200 are for the charity children, and 232 only are free; but then these free-seats are of so inferior a kind, both in their form and situation, that many of the respectable poor would object to going to them; whereas the free-seats in the

Commissioners' Churches have all the real convenience of pews, and are often used by persons of great respectability.

If then my previous remarks be correct, it will appear that the least quantity of additional Church accommodation that should be provided at Hampstead would be for from 900 to 1000 persons, which can only be done by an additional Church or Chapel.

I should rather say that it would be best accomplished in that manner; for, although the Church might be rebuilt on a scale to contain 2000 persons, yet in a building of such great extent, there are few voices capable of being heard in every part; so that although such a Church might be built, the object intended might fail of being accomplished. In the design intended for the Chapel which I have submitted, if 80 pew-sittings were changed to free-sittings, the numbers would be—In pews 411, free-sittings 395, children 114—Total 920.

It has been observed, I understand, as a ground of objection to an additional Chapel, that it would require another Minister; but I need not suggest to you, in reply to this objection, that such a population as yours must require the labour of at least two Ministers, and that where a Chapel is built, provision is usually made for the officiating Minister from the pew-rents; and if, then, the proposed new Chapel contains 400 sittings in pews, let at £1 each per annum, these rents would produce a respectable income, in proportion to the duty to be performed.

Whatever plan is determined on, whether one of these now submitted, or any other, I would take the liberty of recommending to the Trustees, the having contracts and agreements made and settled for the building, or the repairing, previously to the commencement of any work; and to pursue the same system as is followed by His Majesty's Commissioners for building new Churches, which is so complete and thoroughly digested, and proved by repeated trials, that it will ensure the parish from any danger of the works not being performed for the price, and in the manner agreed upon, and thus prevent disappointment, dissatisfaction, and delay. It is on the experience I have had in working on this system, that I presume to offer my plans to your notice*. If any additional information be required that I can give, I shall be happy to wait upon you for that purpose; and should you wish it, I will enter more particularly, and in detail, into the second plan, for the rebuilding the present Church, by proceeding to ascertain the value of the old materials, and probable amount that the Society would contribute to the work.

I would beg leave to request the favour of you not to permit my plans to be seen by any persons unconnected with the management of the business, and when done with, to be so good to have them returned to me.
