

£5 per Quarter should henceforth be allowed for Gratuities
to the Boys from the Choir

February 1851 for defraying the expenses of the Fire Engine

of £10 due to the Inspector at Christmas last and the
sums due to Mr Merryweather amounting to £4.9.0
for the care and repair of the Engine up to the same period be
discharged and that the balance of such proceeds and any money on
hand belonging to the Fire Engine Account be paid over to the Vestry

work done for the Trust amounting in the whole to £18.4.8 were examined
and allowed and a Cheque for the amount was signed by the
Chairman and countersigned by the Clerk.

That in consideration of the satisfactory manner in which Mr Stephens duties as Organist have been discharged and having regard to the savings effected by the recent arrangement with respect to the Church Choir the Salary of the present Organist be raised from 55 Guineas to £65 per annum from Midsummer next and that it be intimated to Mr Stephens that no future application for a further increase to the Organist's Salary will be entertained by the Trust.

Ordered The Amendment was put to the vote and carried

That a Letter be sent to the Organist expressing the desire of the Trust that more simple Chants than those now in use be in future selected for the Church Service

Resolved

That it be referred to the Churchwardens to procure a new Bible and new Prayer Book for the Reading Desk and a new Prayer Book for the Church Desk at a cost not exceeding £15.

Read a Letter from Mr Charles E. Stephens dated the 12th of May last addressed to the Reverend Thomas Ainger dating with reference to the donee expressed by the Trust that more simple Chants than those in use in May last should in future be selected for the Church Service that any suggestion which might be offered on the subject would receive his best attention and that the Chant now and for some time past in use for the Te Deum was his own composition

That the Reverend Thomas Ainger and the Reverend W. P. Chappell be requested to communicate to Mr Stephens the donee of the Trust that the Chant used for the Te Deum should be discontinued and that simple Chants only should be selected for the Church Service

Read a Letter from Mr Charles E. Stephens addressed to the Reverend Thomas Ainger dated the 21st of May last expressing if permission would be given to him to use the Church Organ in giving Lessons to a pupil and to allow the pupil to practice on the Organ once between each weekly Lesson

That a Letter be sent to the Organist dated in reply to the enquiry contained in the Note addressed to Mr Ainger that the Trustees decline giving him (Mr Stephens) permission to use the Church Organ for the purposes requested

Read a Letter from Mr Charles E. Stephens dated the 13th Instant expressing his acknowledgments to the Trustees for the increase to his Salary as Organist and forwarding on account of the payments amounting to £3.12.3 made by him to the Boys and Girls of the National School forming the Church Choir in the Quarter ending at Midsummer last

That the Organ be cleaned and the Case be painted forthwith under the direction of the Churchwardens

The Bills for Salaries to Officers, Gratuities to the Children forming the Church Choir, for Articles supplied and Work done for the Trust and for the balance due to Mr Wells for the new Organ amounting in the whole to £186.17.9 were examined and allowed and authority was given to the Churchwardens and Clerk to sign and countersign a Cheque for the amount

The Churchwardens and Clerk were also authorized to sign and countersign a Cheque for £11 due to Mr C. H. Winfield as Executor of Mrs Ann Winfield deceased for one year's Interest due 5 June 1857 on £200 Balance of Loan of £200 borrowed 5 June 1838 and for one twelfth part of such principal sum of £200

Salaries to Officers, Traders, Bills and Accounts up to Christmas last amounting in the whole to £224.18.9 including £30 agreed at the last meeting to be paid to Mr Longmead as a compensation for the discontinuance from Christmas last of the allowance of £10 per annum for the Parish Clerk's services on the Sunday Evening Service were examined and allowed and Cheques for the several amounts were signed by the Chairman and countersigned by the Clerk to the Trust.

My Friend Miss Sullivan having consulted me about the plan for the designed alterations of the Road leading to Fernal we find it involves not the loss of a Private Road only but of a piece of her Pleasure Grounds and several lofty trees the removal of which would destroy the seclusion so highly prized and expose the entire Promises to every one passing through the Church Yard and Road - Miss Sullivan is of opinion that this would greatly diminish the value of the Property and be prejudicial to her Tenants and as Trustee I cannot advise her to accede to an application involving so great a sacrifice, especially as regards the loss of Gardens - Miss Sullivan was induced to enforce more strictness in closing the Gate from a sense of duty to the Public as much as to herself for the increased traffic consequent on the contiguity of the new Railroad Station and the number of new Buildings was not only calculated to do very much damage to the Road but to render it more dangerous for women and children than formerly - she however made the Road quite free on all Sundays and from what she has expressed to me I believe she is desirous of rendering the Gate as little inconvenient to her Neighbours as may be compatible with the Ends I have explained - Mr Worsley which confined me for several weeks prevented Miss Sullivan from seeing me until lately and explaining to me as the Trustee the Plan of the wished for alterations in the Road - The delay in replying to your application has been unavoidable - He has requested me to convey to you her expressions of regret about having been able sooner to answer it and entertaining as I do the same feelings I need scarcely assure you that the delay arose from

In accordance with your instructions I had examined the tower of Stumpstead Church with reference to the settlement. They are known to be of old standing, but it is also clear that the tower has continued to settle down within the last few years. The result of the settlement is that the tower is the height of 78 feet from the Vestry floor to the springing of the spire which is 6 1/2 inches Westwards, towards the Church, and 2 1/2 inches Southwards. The foundation of the tower I am told is upon planking, but whatever it may be it is certain that there is no immediate danger, and I think it unnecessary to go to the expense of examining

The foundations at present - It would be advisable every two years time to examine the result of any further movement which is owing to have taken place, and it may then be more exactly ascertained whether there is any pushing tendency to lean further from the upright; and if necessary the foundations ought to be examined likewise. The only matter which should be provided against is the chance of alarming the congregation by the falling of pieces of plaster and I should recommend that the East end of the Interior should be examined say every 3 months to see whether there are any loose pieces of ornament or plaster.
